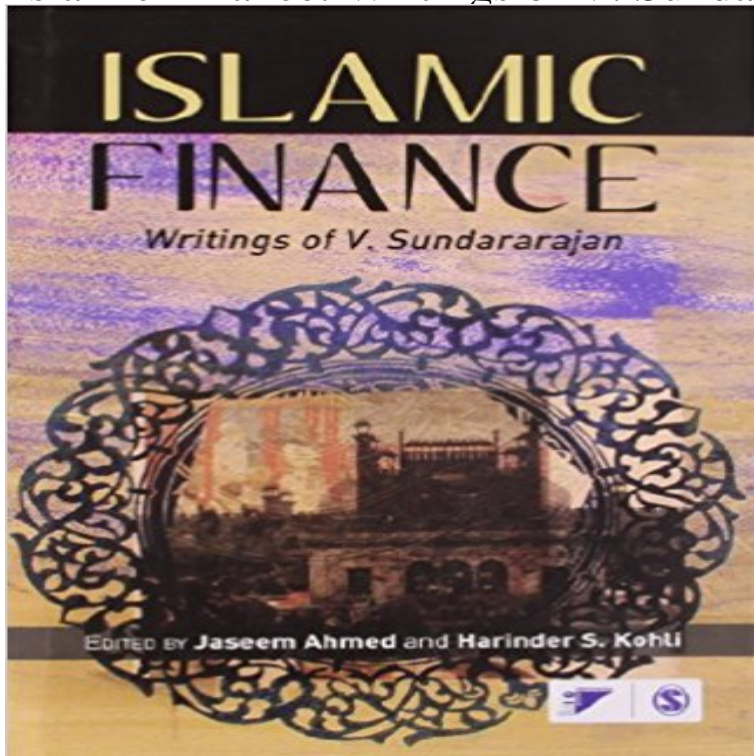


## Islamic Finance: Writings of V. Sundararajan
